**SCHEDULE- I**

**GENERAL TERMS AND CONDITIONS**

- 1.1 The tenderer should clearly state their offers and the address for communication together with their E-mail address, telephone and cell phone No. Any change in the address should immediately be notified to the General Manager, Cattle Feed Factory, Manglia, Cattle Feed Factory Bandol, Cattle Feed Factory, Sironja Sagar & Cattle Feed Factory, Shivpuri so that the correspondence thereafter may be made at their changed address.
- 1.2 The committee will have full right to accept bid in full, partial or split orders for supply of HDPE/PP bags (Multi colour).
- 1.3 The tenderer should have supplied average 20 lakh HDPE/PP bags per year, in the last 3 consecutive years to any Govt/Coopretive organization.
- 1.4 The tenderer should have average turnover of Rs. 3.5 crore per year since last three years.

**2.0 EARNEST MONEY DEPOSIT**

- 2.1 The earnest money will be Rs 400000/- (Rs Four lakhs only) all tenderes are directed to submit earnest money online only.

**3.0 BID OFFER :-**

- 3.1 The prices quoted will be treated as F.O.R. destination, (c/f, Mangliya, Sagar, Shivpuri & Bandol) inclusive of packing forwarding, GST, insurance & transportation charges etc.
- 3.2 The supplier should quote present rates as per Schedule III.
- 3.3 In case of price revision of raw material by Reliance/IOC/IPCL/GAIL/ HALDIA for HDPE/PP or change in excise structure, VAT, Sales Tax by Govt. the prices will be revised proportionately.
- 3.4 Used granules should be HDPE grade Reliance raffia E52009 granules/PP H030SG or equivalent tape grade of IOC/IPCL/GAIL/ HALDIA. Other specifications & tolerance are in accordance to IS:9755-2003.

**4.0 MODE OF DESPATCH:**

- 4.1 On receiving orders from individual Cattle Feed Factory the supply of material at different Cattle Feed Plant, shall be the responsibility of the supplier. Quality inspection and rejection if any, shall be made at the Cattle Feed Plant Sites. The rejected quantity, if any, shall be lifted by the supplier at his own cost. The rejected material shall have to be lifted by the supplier within a week from the date of intimation from the concerned

Cattle Feed Plant. The Cattle Feed Plant shall not be responsible for any deterioration due to delayed lifting of the rejected material by the supplier. **The rejected bags will be returned after got cut from the middle of the bag to ensure identification.**

- 4.2 HDPE/PP Bags to be suitably packed to prevent damages during transit and wrapped with thick polythene/woven HDPE/PP Bags cloth.

5.0 **INSURANCE:**

5.1 Insurance shall be arranged by the Supplier at his cost. The Cattle Feed Factory, Manglia, Bandol, Sagar & Shivpuri will not be responsible for any transit damages and losses.

6.0 **PAYMENT:**

6.1 Our normal terms of payment is 80% payment on acceptance of material after inspection within a period of fifteen days after receipt. The payment shall be made through RTGS only. The remaining 20% Payment will be released after detailed quality testing report within forty days of the receipt.

6.2 Any new/existing supplier will have to make the stencil at his own cost. No extra payment shall be made by Cattle Feed Factory, Manglia, Bandol, Sagar & Shivpuri During the period of contract the design can be changed as per instructions of Committee without any extra charges.

6.3 **For payment: authentic price list of Reliance HDPE HZHD-E52009 GRANULES/PP H030SG OR EQUIVLENT TAPE GRADE OF IOC/IPCL/GAIL/ HALDIA shall be considered & among all lowest raw material price prevailing as on the date of dispatch of material at respective cattle feed plant would be applicable.**

7.0 **STATUS OF TENDER:**

7.1 The acceptance of the tender, and award of the purchase order will be the sole right of the Committee who does not bind himself to accept a tender in whole or in a part. Purchase Committee reserves the right to reject any or all the tenders or their part without assigning any reasons thereof.

7.2 The duration of the tender will be Three years only which can be extended further up to one year and further one more year, on the satisfactory Quality and supply of the material.

8.0 **LIQUIDATED DAMAGES & PENALTIES:**

8.1 Once firm delivery dates are communicated by individual Cattle Feed Factory the same shall be strictly adhered to and this forms the essence of the contract. The supplies should be made as per given schedule. In case they are not followed the in charges of the concerned CFFS

Reserves the right to make alternative purchases from open market and the difference of cost. if any, shall be recoverable from the defaulting supplier. In case the supplies are not made as per schedules the liquidated damages may be charged on the goods not so delivered as under:-

8.2 Supplier will have to inform in writing with appropriate supporting documents about Reliance/IOC/IPCL/GAIL/ HALDIA rate revision/excise duty revision, within 15 days of such revisions, otherwise a penalty @ 5% cost of material per month shall be imposed on supplies made after rate revision. In case of repetition, the supplier shall be blacklisted.

8.3 A penalty of Rs. 500/- (Rupees Five Hundred only) every time shall be imposed in case an insect or foreign matter is found in HDPE/PP Bags.

9.0 **INSPECTION:**

9.1 All the stores are subject to inspection before acceptance by quality control lab. The supplier should contact for the quality control report on 10th day of each supply made. If goods are rejected due to defective or wrong supply, the report of our inspector in this respect shall be final and no correspondence on the subject would be entertained. The rejected goods should be lifted from the CFF within seven days after receipt of our inspection report as stipulated in clause (4.1) failing which the same shall be returned to the supplier at his risk and expenses. The rejected lot will cut from the middle of the bag.

10.0 **SAMPLES:**

10.1 If required the Quality Control Deptt. of Cattle Feed Factory may draw sample equivalent to 10 Bags and shall forward the samples for checking the specification, composition and the standard parameter as laid down in tender specifications by the independent agency as under:

Following Tests shall be carried out by these agencies :-
  1. Measurement Test.
  2. Tensile Strength/ Elongation Test.
  3. Bursting Strength Test.
  4. Ink Quality Test.

10.2 Inspection of equipment, machine or articles shall be arranged by the tenderer at the desired place at his own cost, whenever desired by Cattle Feed Factory. There should be free access to the manufacturers' premises for such inspection.

10.3 The HDPE/PP Bags shall be rejected in case of following:  
A. Incase length/width of the bag is not uniform./ or not as per the norms.  
B. If the weight of bag is less then 130 grams.  
C. Poor stitching/cutting/Printing quality.

11.0 **WHARFAGE/DEMURRAGE:**

11.1 Wharfage/Demurrage etc. on account of incorrect or delayed dispatch of material or documents shall be the responsibility of supplier and shall be recovered from his bill.

11.2 **Rebate :-**

1. If the weight of bags is less than 136 grams deduction shall be made on prorata for the weight from 140 grams up to 130 grams per bag.
2. No rebate shall be deducted if the weight of bag found -4gm.
3. No premium shall be given for higher weight of the bags.
4. Bag shall be rejected & cut if the weight is less than 130 grams.

12.0 **TERMINATION OF AGREEMENT/ CONTRACT:-**

12.1 Any breach of the terms and conditions of contract shall render the contract liable to termination / blacklisting of the firm, in addition to the payment of damage etc.

12.2 The CEO Concerning Dugdh Sangh reserves the right to terminate the contract /agreement on one month notice without assigning any reason.

13.0 **DRAWING & SPECIFICATIONS :-**

Rate should be quoted as per the specifications given in the Schedule - III Committee is not bound to consider the cases in which there are deviations from the prescribed specifications. Only those units shall be eligible to participate in the tender who are equipped with the facilities of manufacturing HDPE/PP Bags (White).

14.0 **FINAL AUTHORITY:-**

14.1 It should be clearly understood that in the event of tenderer failing to accept and execute the supply order, decision of the committee for imposing penalty etc. shall be final and binding on the tenderer.

14.2 At the time of submitting the tender, the tenderer shall supply detailed information about their activities in the enclosed format annexed to form A & B.

14.3 In matters of interpretation of the above clauses, the decision of the committee shall be final and binding on all concerned.

14.4 For all disputes the jurisdiction shall be Indore. No court outside Indore will have any jurisdiction.

15.0 **ARBITRATION:**

15.1 In case of any dispute, if arises between the parties relating to any terms and conditions of the Tender/Agreement and/or regarding the Agreement/Tender before or after the filing of the Tender and/or execution of the Agreement, any party may refer the dispute to a Sole Arbitrator who will be the Managing Director of MPCDF whose decision and award shall be final and binding to both the parties. The arbitration proceedings shall be under and accordance with the provision of Arbitration and Conciliations Act 1996.

16.0 **AGREEMENT/ CONTRACT:**

16.1 Approved tenderer shall have to execute an agreement on a non-judicial stamp Paper of Rs. 1000/- as per terms and conditions of this Tender with the respective Cattle Feed Plant which shall be valid till one year from the date of execution of Purchase Agreement.

The Present agreement will be effective for a period of Three Years from the date of awarding contract. The contract period can be increased up to one year and further again for one year on the ground of satisfactory supply and quality.

The CEO of concerning Dugdha Sangh reserves the right to increase /decrease the requirements of items.
